I attended the NC Region quarterly meeting on April 24<sup>th</sup>. We were voted into the Region unanimously.

The secretary let me know that I would not have the minutes by this meeting, but I will include them in next month's report.

Brain C. the Regional Chair will be reaching out to the Insurance Company this week to get our Area meetings on the policy. He also plans to reach out to our Web Chair.

An invitation was extended for our H&I Chair and PR Chair (if we have one by then) to attend the next regional meeting which will be held on Zoom July 24<sup>th</sup>.

Highlights of the meeting are as follows.
