Recap of Unity Open Forum/round tables February

We began by asking everyone to identify what they believe and/or feel are the major problems facing our area, unity, and ability to carry our message. From that I highlighted what sounded like common themes and grouped them in a list. We asked everyone to prioritize that list in a straw poll based on what they think is the most important or critical to our primary purpose. After that exercise we then prioritized those issues, eliminating anything 5 or below, with people only having 3 choices. The results of both polls are in parenthesis. The top issues are listed last.

Thanks for allowing us to serve Public Relations Subcommittee

Issues identified members in attendance and online

Lack of diversity in convention; have speakers from each home group

Lack of financial responsibility from home groups; not forwarding contributions from 7th Tradition

Money taken before and some groups not trusting as a result of

Racism is pervasive in NA

Area didn't seem racial in 1994; convention subcommittee has evolved from being diverse to majority members who happen to be black; unity is important

Don't experience racism in daily life; came to NA and was welcomed and did not care about being white; suggested serving on convention subcommittee and an area position; can understand members on convention feeling how they did

Capital area has grown; at one time was majority of members being white; racism in not new to our area or NA; go to meetings closest to house

Another area broke up due to racism; helps to go to different meetings; takes personal effort to do that and get out of comfort zone; convention has worked to hold fund raising events and members who happen to be white don't show up; 'purging' meeting list was a mistake during the pandemic Heard racism does not exist in NA but that is not true; don't agree that members on convention should serve elsewhere, people have a choice; do diverse events that support the convention; strive to have more diversity on convention subcommittee; ask groups to provide information about their contributions and where it goes in their reports

Voted me into a position at 90 days clean; are we electing the right people (trusted servants) in the convention subcommittee and we get what we get Lack of open mindedness in our area; different types of events bring out those interested (i.e. campouts no whites, others have majority black); doing the same things in our area

Experience of hanging together and fellowshipping with diverse backgrounds; helps to do service together with different people; will go to another meeting to see long term friends; will cut people off who practice bigotry

Clean since 1987 and seen the changes; NA is like a life raft; need people with different perspectives, experiences, life styles; NA provides opportunities to meet them and learn; tempting to pretend that all is fine; unable to heal without talking about the problem; asc has always been a miracle wondering how it functioned as it was scary at times; important to remain an area and not split; home group has a group conscience determining fund flow (percentage to other levels of service); suggest we continue to hold these

This issue is important; has experienced racism in NA; don't need to come to NA for race issues; come because we all have the same disease; unseen members are important; was put to service upon entering NA; concerned property, money and

prestige has become more important than staying clean and helping others and personal problems, responsibility

Grew up in home that accepted all people and the world is not like that; got clean in small town and the meetings were more diverse than here; went to different meetings and saw a divide by color; moved here from another area; my niche is not convention service; saw another regional convention BOD become 'powerful' and dictate to RSC; home group had not ill intentions with motion but recognized harm caused by the motions and apologized; planned motion brought out many to asc

Grew up in a segregated city; when coming to NA experienced diversity; regional service provided forum for these types of discussions; did not fix racism but stimulated working and serving together; moved here during pandemic; struggled to find meetings that I like

Felt lied to about motivation for motions; served on convention and felt had to defend the convention; and then served on asc and experienced the same; also experienced racism; had to work on personal recovery that racism does not impact ability to carry the message and recovery; why does people who don't support the convention not support it and if its taken away you will do something else

Service is doing the right thing for the right reason; got taken to world convention by other members; attend NA meetings not black or white meetings; go to meetings where I chose; discrimination is more than color; convention lost money at Sheraton downtown; ego can be a problem; convention subcommittee is a part of the asc; questions about financial status are necessary and right; group conscience needs to be adhered to not personal opinion

Wouldn't be clean without support;

Atmosphere of safety prevalent in the room as members are sharing what they feel; understand

better the optics of purging meeting list, motions about convention; don't know how to solve racism inside or outside of NA; might miss it due to being white; some people will hide it; do not get to decide what racism looks like for anyone else; disturbed with some of the fallout and personal attacks when motions came up; has done the same thing before; irony is that the motions if followed through would have began the process earlier; addicts that suffer are harmed when go through strife; listen to each other and talk with each other more

Sponsor took me to meeting with majority white members; then went to meetings the exact opposite demographic; was told that there are no black meetings or white meetings; went to fundraiser where they were only black attendees; have a responsibility to the newcomer to practice unity; today is respectful and everyone is helping today

Once awareness of problem can find the solution; need to focus on now and not in the past that keeps

us twisted; other areas did not do what we are doing right now like surrender and finding our own way; where do we go from here

Saw what happened a couple of months ago; felt some hostility in some meetings; went to meetings out of state and was in the minority but felt welcomed

I feel like there are black meetings and white meetings for cultural environments; perceptions are important; broke bread with a member who did not fit what they thought who they were; easy to blame it on black and white issues; more personal; more diverse events; have seen people told not to go some particular meetings

In general terms what is the definition of racism, is it that 'white folks' don't attend the Cap Area convention and/or fundraisers? Is it that 'white folks' don't attend meetings in southeast Raleigh? Or that people who attend meetings in southeast Raleigh don't attend meetings in Cary? I really think/feel that the word 'racism' needs an agreed

upon definition. It truly may mean something to one person and something else to another

I find race to be an outside issue. It clearly says 'Anyone may join us regardless of age, race, sexual identity, creed, religion or lack of religion'. If there was an issue with in our fellowship about religion, say the Catholics vs the Baptists or Atheists- would be discussing this? What is it about sexual identity or creed? Would we discuss this in this manner? Race isn't an issue in Narcotics Anonymous. Diversity is our strength. HOPE-Hearing Other People's Experience. A member of NA, a white female assaulted and brutally raped etc by a black man. She was prejudice against black men. She came into NA, a racist based on her own perspective. She was able to find solution in the 12 steps of NA and through the Fellowship. She healed her exact nature of her racism. We are here to help each other stay clean just for today
