NA groups also send money to the area committee, money needed to coordinate panels, maintain phonelines, and conduct public information activities. Through their contributions of money and manpower, the groups exercise both their responsibility and their authority for NA services.

Greetings-

On behalf of your ASC Admin committee, this report will be dedicated to a summary of the Town Hall Annual Planning Day. We were tasked with providing this to you along with any recommendations. Below is our report. Keep in mind, this is only a summary. The full details are attached.

There were 27 members in attendance including 4 virtually. We began with a presentation of what planning is in NA, some background information and how it can help us better carry the message. Ideally there are 6 steps (sound familiar?) in the planning process.

- Gather information (Scan)
- Brainstorm issues (prioritize based on what is needed the most to provide better services in helping us carry the message)
- Develop Goals (goals are the destination, well defined, measurable, prioritized based on having the most impact)
- Approaches (how we reach our goals, prioritized based on which approach would help reach the goal in the most efficient way)
- Action plans (each goal has action plan, defines tasks, resources required, timeline, leader, person tracking progress and helping ensure accountability)
- Monitor and Evaluate (frequent reporting, monitor utilization of resources, suggest course corrections if needed to stay focused on goal)

In this initial planning session, we focused on identifying issues, building goals, developing approaches while establishing priorities as related to our area and NA community. We conducted a mock practice planning session utilizing the planning steps with a fake homegroup. This was done to provide those present with a sense of how this works and can help identify issues and solutions. We then created a **vision for our area** of what we think it could look like in 5 years. From that vision we asked ourselves what is in the way of achieving that vision. Once that was completed, the audience was asked to select the issue that is the most impactful barrier to that vision. After grouping similar responses, the group selected **Groups Not Coming to Area and Area Structure is Rigid** as the top issues.

We were able to develop 2 goals to address them: Issue #1: Groups not coming to Area

Goals:

- 75% of the homegroups attending area 75% of the time
- Area understands why groups are not participating

Approaches: See attached details

Issue #2: Area Structure is rigid Goals:

- Service delivery is flexible
- Having a service structure that focuses on outcomes instead of process

Approaches: (we ran out of time for the use of the facility and did not get to)

Next steps are for Admin committee to present this report to you and bring recommendations for next steps to achieve both goals.

Lastly this is my last report serving as your chairperson. I sincerely appreciate your support and partnership this year. I consider my service to you to be an honor and privilege. I hope that you feel I accomplished what you asked of me- provide effective facilitation/leadership and help create an atmosphere of recovery and culture of service during the ASC meeting.
